DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/ ADJUSTMENT OF TARIFF FOR YUNUS ENERGY LIMITED

The Authority vide Decision dated November 2, 2016 approved the quarterly indexation/adjustment of tariff for Yunus Energy Limited (YEL) for the quarters July-September 2016 & October-December 2016.

For the quarterly adjustment request of January-March 2107, YEL requested the Authority to include unadjusted insurance component of tariff in its quarterly adjustment decisions. The Authority considered the request of YEL and found that under upfront tariff 2013, the wind power projects have been given the option whether or not to avail the adjustment of insurance component. Hence, the Authority acceded to the request of the YEL and included the unadjusted insurance component in the quarterly adjustment decision of January-March, 2017.

As the insurance component was not made part of the YEL's quarterly tariff adjustments of July-September 2016 & October-December 2016, hence, the Authority hereby decides to approve the insurance component of Rs. 0.7833/kWh for July-September 2016 and October-December 2016.

The Decision is to be notified in the official gazette in accordance with the provision of Section 31(4) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
