DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/ ADJUSTMENT OF TARIFF FOR ZEPHYR POWER (PVT) LIMITED

Pursuant to grant of "Upfront Tariff dated June 24, 2015 for Wind Power Projects" to Zephyr Power (Pvt) Limited (ZPPL) vide Authority's decision dated May 13, 2016 and the decision of the Authority dated July 08, 2019 in the matter of tariff adjustment of ZPPL's tariff at Commercial Operation Date (COD) notified vide S.R.O. No 1200(I)/2019 dated September 26, 2019, the relevant tariff components of ZPPL in respect of quarter from October 01, 2020 to December 31, 2020 have been revised on account of US CPI, LIBOR/KIBOR and exchange rate variations in accordance with the requisite indexation/adjustment mechanism stipulated in the above referred decision(s) of the Authority indicated in Annex-1.

- 2. The adjusted/ indexed tariff attached as Annex-I is to be notified in the official gazette in accordance with the provision of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.


