Please find enclosed herewith decision of the Authority (01 Page) regarding adjustment in insurance component of Zephyr Power (Private) Ltd.'s tariff for the period March 28, 2021 to March 27, 2022 in Case No. NEPRA/TRF-353/ZPPL-2016.

2. No 1200(1)/2019 dated September 26, 2019, the revised insurance cost and corresponding component of tariff of ZPPL for the period from March 28, 2021 to March 27, 2022 is indicated as under:
