## DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/ADJUSTMENT OF TARIFF FOR MALAKAND-III POWER PROJECT

Pursuant to the Authority's Determination in case No.NEPRA/TRF-81/SHYD0-2007 dated 2<sup>nd</sup> April 2008 and subsequent corrigendum/addendum dated 12th June 2008 notified vide SRO 643(1)/2008 dated 18th June 2008 and the Decision of the Authority dated 27th September 2010 notified vide SRO 1117(1)/2010 dated December 09, 2010 in the matter of adjustment at commercial operation date, the tariff component for the quarter(s) w.e.f Jan 01- March 31, 2022 and April 01- June 30, 2022 have been revised on account of US CPI, CPI (Local), US\$/PKR exchange rate variation in accordance with the requisite indexation/adjustment mechanism stipulated in the aforementioned determination/decision of the Authority.

\*Water Usage is subject to adjustment annually with CPI (General)-Local from date of COD. Since Malakand-III commenced its COD in the month of November, accordingly Water Usage Charge has been indexed in Nov,2021 and the same shall be applicable till Oct 31, 2022.

"For the purpose of indexation of Local O&M component w.e.f Jan 01, 2022 to March 31, 2022 and April 01, 2022 to June 30, 2022 CPIs of October, November & December 2021 were required for Jan-Mar 2022 quarter and CPIs of January, February & March 2022 were required for the April-June 2022 quarter to be used. However, Pakistan Bureau of Statistics has discontinued the publication of CPI for base year 2007-08 w.e.f. July 2020 and replaced it with National CPI for new base year 2015-16. As per relevant provision of the PPA, the tatest available CPI of June 2020 for base year 2007-08 has been used for the instant indexation/adjustment. The indexation of Local O&M is being made on provisional basis, subject to revision upon decision of new reference index value by the Authority.

\*\*\*The Authority vide its decision dated March 10, 2021 replaced CPI Base Year 2007-08 with N-CPI Base Year 2015-16. The decision shall be implemented upon Notification in the Official Gazette.
