


**DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY

Pursuant to the Authority's Determination in case No.NEPRA/TRF-81/SHYDO-2007 dated 2nd April 2008 and subsequent corrigendum/addendum dated 12th June 2008 notified vide SRO 643(1)/2008 dated 18th June 2008 and the Decision of the Authority dated 27th September 2010 notified vide SRO 1117(1)/2010 dated December 09, 2010 in the matter of adjustment at commercial operation date, the tariff component for the quarter w.e.f July 01- Sep 30, 2022 have been revised on account of US CPI, CPI (Local), US\$/PKR exchange rate variation in accordance with the requisite indexation/adjustment mechanism stipulated in the aforementioned determination/decision of the Authority.



3. CPPA (G) to ensure that all payments are consistent with tariff determination(s).



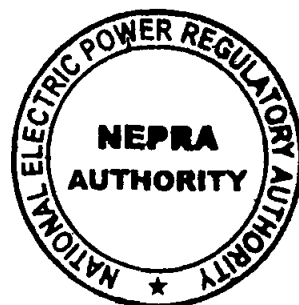

Since Malakand-III commenced its COD in the month of November, accordingly Water Usage Charge has been indexed In Nov,2021 and the same shall be applicable till Oct 31, 2022.</p> <p>**For the purpose of indexation of Local O&M component w.e.f July 01, 2022 to Sep 30, 2022, CPIs of June 2022 was required. However, Pakistan Bureau of Statistics has discontinued the publication of CPI for base year 2007-08 w.e.f. July 2020 and replaced it with National CPI for new base year 2015-16. As per relevant provision of the PPA, the latest available CPI of June 2020 for base year 2007-08 has been used for the instant indexation/adjustment. The indexation of Local O&M and WUC are being made on provisional basis, subject to revision upon decision of new reference index value by the Authority.</p> <p>***The Authority vide its decision dated March 10, 2021 replaced CPI Base Year 2007-08 with N-CPI Base Year 2015-16. The decision shall be implemented upon Notification in the Official Gazette.</p>
