DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/ADJUSTMENT OF TARIFF FOR STAR HYDRO POWER LIMITED

Pursuant to the decision of the Authority dated 27th January 2012 in the matter of request filed by Central Power Purchasing Agency for approval of negotiated tariff regarding procurement of power from Star Hydropower (Pvt.)
