

**COMPONENT OF TARIFF FOR OURSUN PAKISTAN LIMITED**


Pursuant to the decision of the Authority dated November 20, 2019 in the matter of tariff adjustment of Oursun Pakistan Limited (OSPL) at Commercial Operation Date (COD) and motion for recalculation decision dated January 10, 2020 notified vide S.R.O. 179(I)/2020 dated March 4, 2020 and corrigendum of S.R.O. dated April 7, 2020, the insurance cost and corresponding component of tariff of OSPL for 4<sup>th</sup> operational year i.e. from November 30, 2021 to November 29, 2022 has been revised as under:



November 30, 2021 to November 29, 2022	37,550,940	0.4763

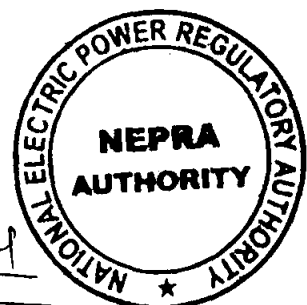
