

**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR CHINA
POWER HUB GENERATION COMPANY PRIVATE LIMITED**

1. Pursuant to the decision of the Authority dated February 12, 2016 in the matter of Approval of Upfront Coal Tariff for 2x660 MW coal power plant of China Power Hub Generation Private Limited (hereafter "CPHGCL"), decision dated September 23, 2016 regarding Suo Moto Review Proceedings in the Fuel Price Adjustment Mechanism determined in Upfront Coal Tariff and decision dated July 28, 2017 regarding approval of cost of dedicated jetty along with coal transshipment services, the fuel portion of the energy charge part of CPHGCL's tariff needs to be adjusted for variation in coal price. CPHGCL requested weighted average coal price of US\$ 129.06/ton for coal consumed during the month of June 2019. CPHGCL requested fuel cost component of Rs. 6.5865/kWh for the month of June 2019 which was found on higher side. In accordance with the prescribed mechanism, the revised coal price for the shipment # 03 has been worked out and attached as Annexure to this decision. The revised fuel cost component of energy charge part of CPHGCL's tariff for Pre-COD sale, indicated hereunder shall be immediately applicable to the units delivered during the month:

2. Coal transshipment cost has been worked out on the basis of indexed capacity fee for 91 days of pre-COD period, handling quantity of 500,000 tons of coal during pre-COD period, indexed bunker and O&M cost in accordance with the decision of the Authority in the matter of approval of Transshipment Cost.
3. The revised fuel cost component along with revised coal price and marine freight charges attached as **Annex-I, Annex-II & Annex-III** respectively are to be notified in the official gazette, in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
4. CPPA (G) to ensure that all payments are consistent with the tariff determinations.

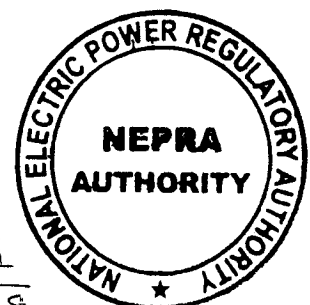

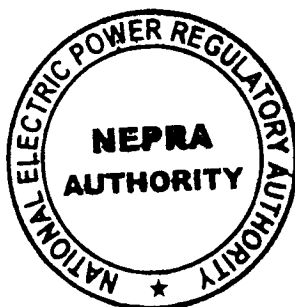
