DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/ ADJUSTMENT OF TARIFF FOR CHINA POWER HUB GENERATION COMPANY PRIVATE LIMITED.

- Pursuant to the decision of the Authority dated 12th February 2016 in the matter of application of China Power Hub Generation Company Private Limited (hereafter "CPHGCL") for unconditional acceptance of upfront coal tariff for 2x660 MW coal power plant and decision of the Authority dated November 7, 2018 regarding ash disposal & limestone, the relevant tariff components in respect of October-December 2019 quarter has been revised on account of US CPI, CPI (General), KIBOR, exchange rate, coal price(s) and coal calorific value(s) variation.
- 2. Ash Disposal and Limestone components of tariff are subject to adjustment at the time of COD, therefore, there is no change in the ash disposal and limestone components and shall be revised after COD adjustment.
- 3. The decision of the Authority dated August 8, 2019 in matter of approval of jetty O&M tariff is still to be notified in the Official Gazette, therefore, jetty O&M components shall be indexed/adjusted after the notification of the Authority decision in the Official Gazette.
