


DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMNET FOR THE MONTH OF JULY 2023 FOR CHINA POWER HUB GENERATION COMPANY PRIVATE LIMITED.

- 1. Pursuant to the decision of the Authority dated February 12, 2016 in the matter of Approval of Upfront Coal Tariff for 2x660 MW coal power plant of China Power Hub Generation Private Limited (hereafter "CPHGCL") and decision dated September 23, 2016 regarding Suo Moto Review Proceedings in the matter of Fuel Price Adjustment Mechanism determined in Upfront Coal Tariff, the fuel portion of the energy charge part of CPHGCL's tariff needs to be adjusted for variation in coal price. CPHGCL requested weighted average coal price of Rs. 64,525/Ton for coal consumed during the month of July 2023. CPHGCL requested fuel cost component of Rs. 24.5572/kWh for the month of July 2023.
- 2. It was noted that in case of actual CV < 5,850 kcal/kg and < 5,700 kcal/kg, CPHGCL used base CV of 5,850 kcal/kg and 5,700 kcal/kg instead of 6,000 kcal/kg and 5,500 kcal/kg which is against the pricing mechanism. Accordingly, the price of coal of CV < 5,850 kcal/kg and < 5,700 kcal/kg has been adjusted on the basis of 6,000 kcal/kg and 5,500 kcal/kg, respectively.</p>
- 3. In accordance with the prescribed mechanism and on the basis of information and documents submitted by PQEPCL, the revised coal price has been worked out and attached as annex to this decision. The revised FCC of energy charge part of PQEPCL's tariff indicated hereunder shall be immediately applicable to the units delivered during the month:

- 4. The above referred revised fuel cost component along with revised spot coal prices, attached as **Annex-I & Annex-II**, respectively, are to be notified in the official gazette, in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
- 5. CPPA (G) to ensure that all payments are consistent with the tariff determination(s).
