DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMNET FOR THE MONTH OF SEPTEMBER 2024 FOR CHINA POWER HUB GENERATION COMPANY PRIVATE LIMITED.

- 1. Pursuant to the decision of the Authority dated February 12, 2016 in the matter of Approval of Upfront Coal Tariff for 2x660 MW coal power plant of China Power Hub Generation Private Limited (hereafter "CPHGCL") and decision dated September 23, 2016 regarding Suo Moto Review Proceedings in the matter of Fuel Price Adjustment Mechanism determined in Upfront Coal Tariff, the fuel portion of the energy charge part of CPHGCL's tariff needs to be adjusted for variation in coal price. CPHGCL requested weighted average coal price of Rs. 48,417.25/Ton for coal consumed during the month of September 2024. CPHGCL requested fuel cost component of Rs. 18.5525/kWh for the month of September 2024.
- 2. The NEPRA Appellate Tribunal vide its Order dated September 7, 2023 awarded interim relief to CPHGCL and granted stay order on application of price differential w.e.f. August 2023 onwards subject to submission of an undertaking by CPHGCL. The Order of the Tribunal is reproduced hereunder:

"Respondents are directed to submit reply of this petition within 07 days positively. Meanwhile as ad interim relief, on submission of undertaking by the appellant, to the satisfaction of Registrar NEPRA, Islamabad within 07 days from today to the effect that in case the appeal fails, the Authority may recover the 'Coal Price Differential' (recovery whereof stayed by this order) from the future invoices, as per law/rules/judgment, Respondent No. 02 will not deduct 'Coal Price Differential' w.e.f. August and September 2023 and onwards invoices, till further orders or till final decision of appeal, whichever is earlier."

- 3. CPHGCL submitted the required undertaking through its legal counsel vide letter No. LLC/2023/NEPRA/12 dated September 8, 2023. Accordingly, price differential have not been applied in the instant adjustment.
- 4. CPHGCL paid the CIF price in Chinese Yuan (CNY) to its coal supplier and calculated the price of shipment No. 84 in CNY instead of USD. CPHGCL calculated CV adjusted price and marine freight by using the exchange rate provided by coal supplier, while other charges were calculated by using the average Rs./USD and Rs./RMB exchange rates published by NBP during the month of November 2022. The requested cost is not in line with the approved mechanism provided in the decision dated September 23, 2016, therefore, the imported shipment No. 84 price has been calculated as per the prescribed mechanism.
- 5. CPHGCL consumed coal in September 2024 from Shipment No. 82 part of which was also consumed in August 2023 and November 2023. CPHGCL also consumed coal from Shipment No. 85 part of which was also consumed in November 2023, May 2024 to July 2024.





- 6. The price of Shipment No. 82 was assessed as Rs. 84,830/ton (US\$ 381.60/ton), while, determining fuel cost component for the month of August 2023. The price of Shipment No. 85 was assessed as Rs. 42,440/ton (US\$ 150.86/ton), while, determining fuel cost component of November 2023.
- 7. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under which shall be hereafter called as decision of the Authority in the matter:

"Based on the documentary evidence and information submitted by CPHGCL, the fuel cost component of energy charge part of CPHGCL's tariff is adjusted for variation in coal price for the month of September 2024."

The revised FCC of energy charge part of CPHGCL's tariff indicated hereunder shall be immediately applicable to the units delivered during the month:

9. The revised fuel cost component attached as Annex-I is to be notified in the official gazette, in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.

10. CPPA (G) to ensure that all payments are consistent with the tariff determination(s).


