## SUO MOTO REVIEW PROCEEDINGS REGARDING INSERTION OF OMITTED CLAUSE IN THE MATTER OF APPROVED UPFRONT COAL TARIFF DATED 12th FEBRUARY 2016 FOR CHINA POWER HUB GENERATION COMPANY (PVT) LIMITED

- 1. The Authority vide its decision No. NEPRA/TRF-342/CPFIGCL-2016/2043-2045 dated 12<sup>th</sup> February 2016 approved upfront tariff in favor of M/s. China Power Hub Generation Company (Pvt) Limited for its 1320 MW coal power plant.
- 2. An omission has been observed in the above decision wherein the following Clause could not be reflected in Para 3(II)(xviii);

"(8) The cost of lime stone and ash disposal will be adjusted on actual basis at the time of COD."

3. The Authority has therefore, decided to insert Clause 8 after the Clause 7 in Para 3(II)(xviii) of the above mentioned decision.

## <u>Order</u>

4. In pursuance of Section 7(2)(g) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 read with Regulation 3 of NEPRA (Review Procedure) Regulations, 2009 the Authority has decided to insert the following Clause 8 after Clause 7 under Para 3(II)(xviii) of the decision dated 12<sup>th</sup> February 2016 for M/s China Power Hub Generation Company (Pvt) Limited notified vide SRO No. 340(I)/2016 dated 15<sup>th</sup> April 2016.

"(8) The cost of lime stone and ash disposal will be adjusted on actual basis at the time of COD."

5. The above Order of the Authority shall be notified in the Official Gazette in terms of Section 31(7) of the Regulations of Generation, Transmission and Distribution of Electric Power Act, 1997.
