**SUO MOTO REVIEW PROCEEDINGS REGARDING INSERTION OF OMITTED CLAUSE
IN THE MATTER OF APPROVED UPFRONT COAL TARIFF DATED 13TH FEBRUARY
2015 IN THE MATTER FOR GRANGE POWER LIMITED**

1. The Authority vide its decision No. NEPRA/TRF-289/GPL-2015/1872-1874 dated February 13, 2015 approved upfront tariff in favor of M/s. Grange Power Limited for its 150 MW coal power plant.
2. An omission has been observed in the above decision wherein the following Clause could not be reflected in Para 3(II)(xviii);

"(8) The cost of lime stone and ash disposal will be adjusted on actual basis at the time of COD."

3. The Authority has therefore, decided to insert Clause 8 after the Clause 7 in Para 3(II)(xviii) of the above mentioned decision.



In pursuance of Section 7(2)(g) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 read with Regulation 3 of NEPRA (Review Procedure) Regulations, 2009 the Authority has decided to insert the following Clause 8 after Clause 7 under Para 3(II)(xviii) of the decision dated 13th February 2015 for M/s Grange Power Limited notified vide SRO No. 557(I)/2015 dated 26th May 2015.

"(8) The cost of lime stone and ash disposal will be adjusted on actual basis at the time of COD."

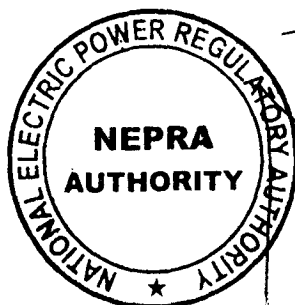
