DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/ ADJUSTMENT OF TARIFF FOR PORT QASIM ELECTRIC POWER COMPANY (PRIVATE) LIMITED.

Pursuant to the Decision of the Authority dated February 13, 2015 in the matter of approval of upfront coal tariff for 2x660 MW coal power plant of Port Qasim Electric Power Company (hereafter "PQEPCL"), clarifications issued by the Authority for pre-COD sale of energy for similar power plants and pursuant to Part-V of Schedule I of the Power Purchase Agreement, the relevant tariff components in respect of January-March 2018 quarter have been revised on account of US CPI, CPI (General), exchange rate, KIBOR, coal price and coal calorific value variation. Ash Disposal and Limestone components of tariff are subject to adjustment at the time of COD, therefore, there is no change in the ash disposal and limestone components and shall be revised after COD adjustment. The revised tariff indicated hereunder shall be immediately applicable on units delivered basis on below mentioned relevant quarter:
