Please find enclosed herewith subject decision of the Authority along with Annex-I (total 02 pages) regarding adjustment in Insurance Component of Capacity Charge Part of Tariff on account of Actual Insurance Premium for the period **March 30, 2023 to March 29, 2024** in respect of Port Qasim Electric Power Company (Private) Ltd. DECISION OF THE AUTHORITY IN THE MATTER OF ANNUAL ADJUSTMENT IN INSURANCE COMPONNET OF CAPACITY CHARGE PART OF TARIFF FOR PORT QASIM ELECTRIC POWER COMPANY (PRIVATE) LIMITED

1. Pursuant to the Decisions of the Authority dated February 13, 2015 in the matter of approval of upfront coal tariff for 2x660 MW coal power plant of Port Qasim Electric Power Company (hereafter "PQEPCL") and dated September 27, 2019 in the matter of tariff adjustment at Commercial Operation Date, the insurance component of tariff is subject to annual adjustment as per actual cost. PQEPCL requested to revise the insurance component of Rs. 0.1929/kW/Hour on the basis of insurance cost of Rs. 2,100,022,035 for the sixth agreement year. PQEPCL in support provided copies of insurance policies, sales tax invoices and payment receipts. The details of requested insurance cost is hereunder:

"Based on information and documentary evidence(s) provided by PQEPCL and in accordance with the Schedule VIII of Power Purchase Agreement, the insurance component of capacity charge part of tariff has been revised for the period March 30, 2023 to March 29, 2024 (366 days) on the basis of insurance premium of Rs. 2,100,022,035."

3. The revised insurance cost component of capacity charge part of tariff indicated hereunder shall be immediately applicable:
