

1. Pursuant to the decision of the Authority dated October 18, 2016, in the matter of approval of Thar Coal Upfront Tariff for 330 MW Coal Power Plant of Thar Energy Limited (TEL) and based on the documentary evidence and information submitted by TEL, the variable and fixed fuel cost components of the energy charge part of TEL's tariff are adjusted for variation in Thar coal price(s) for the month of October 2022. 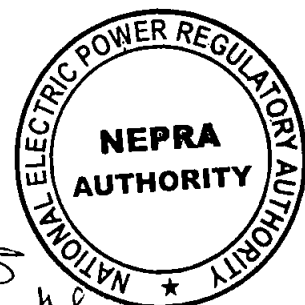
