
Dear Sir,


**DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/ ADJUSTMENT OF
TARIFF FOR AL-MOIZ INDUSTRIES LIMITED**

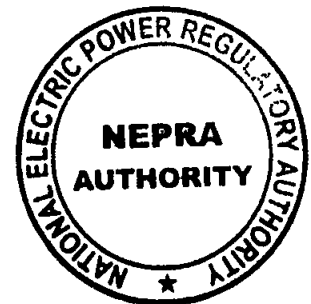
1. Pursuant to the decision of the Authority dated February 22, 2019 in the matter of tariff adjustment of Al-Moiz Industries Limited ("AMIL") at Commercial Operation Date (COD) notified vide S.R.O No.1576(I)/2019 on December 26, 2019, the relevant tariff components of AMIL in respect of quarter from April 01, 2021 to June 30, 2021 have been revised on account of US CPI, KIBOR/LIBOR and exchange rate variation (USD/PKR) in accordance with the requisite indexation/adjustment mechanism stipulated in the above referred decision of the Authority indicated in **Annex-I**.
2. The above referred adjusted/ indexed tariff attached as **Annex-I** is to be notified in the official gazette in accordance with the provision of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
3. CPPA-G to ensure that all the payments are consistent with tariff determination.



* For the purpose of indexation of local O&M components for Apr-Jun 2021 quarter, CPI for Feb 2021 was required to be used. However, Pakistan Bureau of Statistics has discontinued the publication of CPI for base year 2007-08 w.e.f. July 2020 and replaced it with National CPI for new base year 2015-16.

The Authority vide its decision dated March 10, 2021 replaced CPI Base Year 2007-08 with N-CPI Base Year 2015-16, however, that decision shall be implemented upon Notification in the Official Gazette.

As per relevant provision of the EPA, the latest available CPI of June 2020 for base year 2007-08 has been used for the instant indexation/adjustment. The indexation of Local O&M components is being made on provisional basis, subject to revision upon notification of the Authority's decision of revised index.
