**REVIEW DECISION OF NATIONAL ELECTRIC POWER REGULATORY AUTHORITY IN THE MATTER OF QUARTERLY INDEXATIONS/ ADJUSTMENTS OF TARIFF FOR CHINIOT POWER LIMITED**

1. The Authority has noted an inadvertent calculation error in the debt servicing component approved in a number of quarterly indexation decisions of Chiniot Power Limited ("CPL") and decided to rectify the same under Section 7 of Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 read with Regulation 3 of National Electric Power Regulatory Authority (Review Procedure) Regulations, 2009. 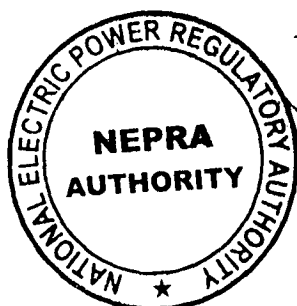
