DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/ ADJUSTMENT OF TARIFF FOR HAMZA SUGAR MILLS LIMITED (HSML)

Pursuant to the decision of the Authority dated September 12, 2014 in the matter of application of Hamza Sugar Mills Limited (HSML) opting for Upfront Tariff notified vide S.R.O No. 1033(1)/2014 dated November 11, 2014, decision of the Authority dated May 12, 2017 regarding One Time Adjustment of Upfront Tariff of HSML notified vide S.R.O No.627(I)/2017 dated July 07, 2017 with supersession of previous S.R.O dated November 11, 2014, the tariff of HSML in respect of quarter October-December 2019 has been adjusted/indexed on account of US CPI, CPI (General), exchange rate and KIBOR variation in accordance with the requisite indexation/adjustment mechanisms stipulated in the above referred decision(s) of the Authority. The revised tariff for the quarter October-December, 2019 indicated in Annex-I, shall be applicable for the energy sold during the specified quarter.
