

**DECISION OF THE AUTHORITY REGARDING FUEL PRICE ADJUSTMENTS IN THE TARIFF OF JDW SUGAR MILLS LIMITED UNIT II (JDWSML-II)**

Pursuant to the Authority's determination in the Case No. NEPRA/TRF-253/JDWSML-2013 dated November 6, 2013 in the matter of application of JDW Sugar Mills Limited opting for upfront tariff notified vide S.R.O No 1059(I)/2013 dated December 12, 2013, Decision of the Authority dated September 14, 2015 regarding One Time Adjustment of Upfront Tariff of JDW Sugar Mills Unit-II notified vide S.R.O No 1240(I)/2015 dated December 10, 2015 with supersession of previous S.R.O dated December 12, 2013, fuel adjustment needs to be made in the energy charge part of its tariff on account of fuel price variation on yearly basis. JDWSML-II in accordance with the Authority's determination requested for adjustment of fuel cost component.

2. As per decision of the Authority:


*"To safeguard interest of consumers, the Authority may review the fuel pricing mechanism stipulated above in accordance with NEPRA applicable law, after due consultation with the affected/interested parties, if it is deemed that there is exorbitant/unreasonable increase in international coal prices. Similarly, to mitigate risk to the power producer and to encourage the investors to put up bagasse based(indigenous fuel) cogeneration projects, the reference CIF coal price of US\$ 100.67/ton used at the time of this determination shall be considered the floor/minimum price for the purpose of the Fuel cost Component."*


3. The details of the allowed fuel cost components are as under:


Period	Revised Fuel Cost Component Rs./kWh
w.e.f. 1 <sup>st</sup> July , 2015 to 30 <sup>th</sup> September 2015	5.9822
w.e.f. 1 <sup>st</sup> October , 2015 to 30 <sup>th</sup> September 2016	6.1471
w.e.f. 1 <sup>st</sup> October 2016 to 30 <sup>th</sup> September 2017	6.1677

4. The above revised fuel cost component is based on the minimum floor coal price of US\$ 100.67/ Ton vide the Authority's referred decision dated September 14, 2015.
5. The above referred revised tariff components are to be notified in the official gazette, in accordance with the provisions of Section 31(4) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.

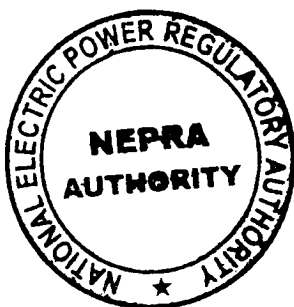


