


REVIEW DECISION OF NATIONAL ELECTRIC POWER REGULATORY AUTHORITY IN THE MATTER OF QUARTERLY INDEXATIONS/ ADJUSTMENTS OF TARIFF FOR JDW SUGAR MILLS LIMITED UNIT-III


1. The Authority has noted an inadvertent calculation error in the debt servicing component approved in a number of quarterly indexation decisions of JDW Sugar Mills Limited Unit-II ("JDWSML-III") and decided to rectify the same under Section 7 of Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 read with Regulation 3 of National Electric Power Regulatory Authority (Review Procedure) Regulations, 2009. Accordingly, the debt servicing components appearing in Annex-I of the tabulated below Authority's decisions in the matter of quarterly indexations/adjustments of JDWSML's tariff shall be replaced as per following:


