2. In the Annexure of the above said decision, the quarter mentioned at last column as "Jan-Mar, 2021" shall be read as "Jan-Mar, 2022".

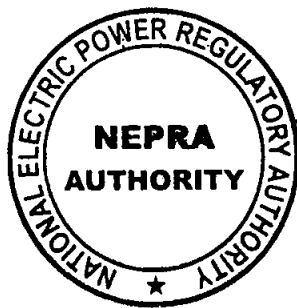
