
Decision of the Authority in the Matter of Adjustment in Insurance Component of Capacity Charge Part of Tariff for Atlas Power Limited (APL)

Pursuant to the decision of the Authority dated 19th May 2010 in the matter of adjustment at commercial operation date, on the basis of information provided by APL, the insurance component of capacity charge part of tariff of APL has been revised on the basis of actual insurance premium of Rs. 157.226 million net of 16% Federal Exise Duty of Rs. 24.907 million in accordance with the Schedule VIII of the Power Purchase Agreement (PPA). The revised insurance component of capacity charge part of tariff indicated hereunder shall be immediately applicable:


