THE MATTER **ADJUSTMENT OF** OF THE **AUTHORITY** IN INSURANCE COMPONENT OF CAPACITY CHARGE PART OF TARIFF FOR ATI POWER LTD FOR THE PERIOD FROM DECEMBER 18, 202 TO DECEMBER 17, 2023.

1. Pursuant to the decision of the Authority dated May 19, 2010 in the matter of tariff adjustment at Commercial Operation Date (COD) notified vide S.R.O 389(I)/2010 dated June 4, 2010 regarding Atlas Power Limited (APL), the insurance component of tariff is subject to adjustment as per actual annually. APL vide its letter dated December 20, 2022 requested to approve insurance component of Rs. 0.1949/kW/h for the period from December 18, 2022 to December 17, 2023. APL in support of its request provided copies of insurance policies, premium calculation, premium payment evidences, details of no claim bonus and quotations from three independent insurance companies. The details of requested insurance cost net of sales tax is as under:

2. As per the documentary evidences, the actual insurance premium (net of sales tax) paid by APL is Rs. 265,257,223. Accordingly, on the basis of net insurance premium and as per Schedule VIII of Power Purchase Agreement, the insurance component of capacity charge part of tariff has been revised.
