#### DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJSUTMENT FOR ATTOCK GEN. LTD. (AGL) (Case No. NEPRA/TRF-55/AGL-2006)

Pursuant to the decision of the Authority dated July 30, 2009 in case No. NEPRA/TRF-55/AGL-2006 regarding Attock Gen. Ltd. (hereinafter "AGL"), the fuel portion of the energy charge part of AGL's tariff has been adjusted for the variation in furnace oil prices for the month of July 2010.
