Please find enclosed the decision of the Authority along with revised schedule of tariff (Annex-I) (02 pages) in respect of quarterly indexation / adjustment of tariff for Attock Gen Ltd. (AGL) in Case No. NEPRA/TRF-55/AGL-2006. As per Paragraph 94 of the Tariff Determination dated September 4, 2006, the revised capacity charge for January – March, 2010 quarter shall be immediately applicable with effect from January 01, 2010.

DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/ADJUSTMENT OF TARIFF FOR ATTOCK GEN. LIMITED (AGL)
