3. Please note that revised energy charge part of tariff relating to fuel to be notified in the official Gazette is attached as Annex-I & II.

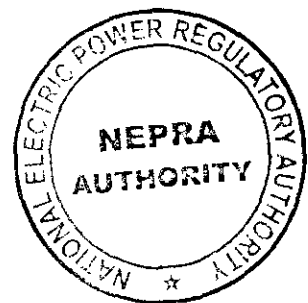


**DECISION OF THE AUTHORITY IN THE MATTER OF
FUEL PRICE ADJUSTMENT FOR ATTOCK GEN. LIMITED (AGL)**


Pursuant to the decision of the Authority dated July 30, 2009 in case No. NEPRA/TRF-55/AGL-2006 regarding Attock Gen. Ltd.
