- 1. Pursuant to the decision of the Authority dated 24th May 2010 in the matter of motion for leave for review filed against the decision of the Authority at Commercial Operation Date (COD) on the basis of information provided by AGL, the insurance component of capacity charge part of tariff of AGL has been revised on the basis of insurance cost of Rs. 106,357,636 million in accordance with the Schedule VIII of the Power Purchase Agreement (PPA).
