Pursuant to the decision of the Authority dated November 16, 2017 in the matter of tariff adjustment of Best Green Energy Pakistan Limited (BGEPL) at Commercial Operations Date (COD) notified vide SRO 23(I)/2018 dated January 05, 2018, the insurance cost and corresponding component of tariff of BGEPL for the period from August 01, 2020 to July 31, 2021 is given as under:
