DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE
COMPONENT OF TARIFF FOR CREST ENERGY PAKISTAN LIMITED

Pursuant to the decision of the Authority dated November 16, 2017 in the matter of tariff adjustment of Crest Energy Pakistan Limited (CEPL) at Commercial Operations Date (COD) notified vide SRO 262(I)/2018 dated February 19, 2018, the insurance cost and corresponding component of tariff of CEPL for the period from August 01, 2020 to July 31, 2021 has been revised as under:
