


# DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/ ADJUSTMENT OF TARIFF FOR ENGRO POWERGEN QADIRPUR LIMITED

Pursuant to the decisions of the Authority in the matter of adjustment at Commercial Operation Date (COD) regarding Engro Powergen Qadirpur Limited (EPQL), formerly Engro Energy Limited dated 3<sup>rd</sup> November 2010, 26<sup>th</sup> August 2011 and Corrigendum dated May 14, 2012, the tariff of EPQL in respect of October-December 2012 quarter has been revised on account of US CPI, WPI (Local), exchange rate, LIBOR and KIBOR variation in accordance with the requisite indexation/adjustment mechanism stipulated in the decisions of the Authority. \* For the purpose of indexation of local O&M for October-December 2012 quarter, WPI (Manufactures) for August 2012 was required to be used. However, with the revision of base values of WPI from 2000-01 to 2007-08 by Federal Bureau of Statistics, the commodity group of WPI (Manufactures) has now ceased to exist and the latest available WPI (Manufactures) pertaining to July 2011 has been used for the indexation. The local O&M component will be revised, if required, in terms of Para 12.3 of Part V of Schedule 1 of the PPA on determination of new index by the Authority.
