
Dear Sir,


Pursuant to Para 4(I) of the decision of the Authority dated 1st April 2011 in the matter of motion for leave for review against the Authority's COD decision dated 3rd November 2010 regarding Engro Powergen Qadirpur Limited (EPQL), formerly Engro Energy Limited, on the basis of information provided by EPQL, the insurance component of capacity charge part of tariff for the period 23-Apr-2014 to 23-Apr-2015 has been revised on the basis of insurance premium Rs. 151,406,773/- net of 16% Federal Excise Duty (FED).


The revised insurance component of capacity charge part of tariff indicated hereunder shall be immediately applicable:




