DECISION OF THE AUTHORITY IN THE MATTER OF REIMBURSEMENT OF 7.5% WITHHOLDING TAX ON DIVIDENDS FOR ENGRO POWERGEN QADIRPUR LIMITED

Pursuant to the decisions of the Authority in the matter of adjustment at Commercial Operation Date (COD) regarding Engro Powergen Qadirpur Limited (EPQL) dated 3rd November 2010 and 26th August 2011, withholding tax on dividend is a pass through item and the power purchaser shall make payment on account of withholding tax at the time of actual payment of dividend as hourly payment spread over a period of 12 months.
