


**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR
ENGRO POWERGEN QADIRPUR LIMITED**


Pursuant to the Decision of the Authority dated April 01, 2011 in the matter of Motion for Leave for Review against the Decision of the Authority at COD, Corrigendum of the Authority dated May 14, 2012 and Decision of the Authority dated June 9, 2016 in the case of Engro Powergen Qadirpur Limited (hereinafter "EPQL"), the fuel portion of energy charge part of tariff of EPQL has been adjusted for variation in gas price. Oil & Gas Regulatory Authority (OGRA) dated October 4, 2018 has notified gas price of Rs. 629/MMBTU for the IPPs. Based OGRA's notification, revised energy charge part of EPQL's tariff relating to fuel indicated hereunder shall be immediately applicable on units delivered basis:


Period	Revised Fuel Cost Component Rs./kWh



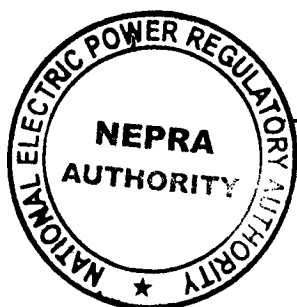
