DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/ ADJUSTMENT OF TARIFF FOR ENGRO POWERGEN QADIRPUR LIMITED

Pursuant to the Decision of the Authority dated 1st April 2011 in the matter of Motion for Leave Review against Decision for tariff adjustments on Gas operations at Commercial Operation Date, Corrigendum dated 14th May 2012, Decision of the Authority dated 20th December 2012 in the matter of change of index from WPI (Manufacture) to CPI (General), Decision of the Authority dated 17th September 2013 in the matter of tariff adjustments on High Speed Diesel and mixed fuel regarding Engro Powergen Qadirpur Limited (EPQL), formerly Engro Energy Limited and Decision of the Authority dated 9th June 2016, the relevant tariff components of EPQL in respect of July to September 2018 quarter have been revised on account of US CPI, CPI (General), exchange rate, LIBOR and KIBOR variation in accordance with the requisite indexation/adjustment mechanism stipulated in the decisions of the Authority.
