Please find enclosed herewith the decision of the Authority along with revised Tariff Scheduel (Annex-I) (02 pages) regarding adjustment in Insurance Component of Capacity Charge Part of tariff on account of Actual Insurance Premium for the period from 23.04.2018 to 23.04.2019 in respect of Engro Powergen Qadirpur Ltd. in Case No. NEPRA/TRF-72/EPQL-2007.

- 2. The decision is being intimated to the Federal Government for the purpose of notification of adjustment in the approved tariff through the official Gazette pursuant to Section 31 (7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997.

Decision of the Authority in the Matter of Adjustment in Insurance Component of Capacity Charge Part of Tariff for Engro Powergen Qadirpur Limited (EPQL)

- 1. Pursuant to decisions of the Authority dated 1st April 2011 and 17th September 2013, Engro Powergen Qadirpur Limited (EPOL) vide letter dated July 31, 2018 filed application for adjustment of insurance component of capacity charge part of tariff for the period 23rd April 2018 to 23rd April 2019 on the basis of insurance premium of Rs. 230,833,870/- net of Federal Excise Duty/Sales Tax on Services.
- 2. NEPRA vide letter No. NEPRA/SAT-I/TRF-72/EPQL-2007/18725 dated November 29, 2018 indicated EPQL that the requested insurance premium is substantially on higher side as compared to other similar IPPs and directed to justify the requested cost vis a vis other IPPs. EPQL was also directed to provide details of No Claim Bonus received from the insurer during the preceding years.
- 3. EPQL vide letter No. EPQL/HO/C/NEPRA/111 dated December 12, 2018 submitted that as per the Authority's Determination the company is permitted the adjustment of the actual insurance cost, not exceeding 1.35% of the EPC cost, whereas the insurance amount claimed in request equates to 1.23% of the EPC (USD 153,414000 at USD/PKR rate of 121.6). EPQL further submitted that the company shall endeavor to ensure alignment of its future insurance policies (as far as practicable) with those of the referenced IPPs for subsequent periods.
- 4. The Authority has considered the submissions made by EPQL and decided to allow Rs. 216,841,506/- after adjusting the No Claim Bonus of Rs. 13,992,364. Accordingly, the insurance component of capacity charge part of tariff for the period 23rd April 2018 to 23rd April 2019 has been revised. The revised insurance component of capacity charge part of tariff indicated hereunder shall be immediately applicable:
