
DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT ON HSD FOR EENGRO POWERGEN QADIRPUR LIMITED

Pursuant to the Authority's decisions dated September 17, 2013, December 10, 2014 and June 9, 2016 in the case of Engro Powergen Qadirpur Limited, Formerly Engro Energy Limited, (hereinafter "EPQL"), the fuel portion of energy charge part of tariff of EPQL is required to be adjusted for variation in HSD price(s).

Based on revised HSD price, the fuel portion of energy charge part of tariff of EPQL has been adjusted and indicated hereunder which shall be immediately applicable on units delivered basis:
