DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT ON HSD FOR ENGRO POWERGEN QADIRPUR LIMITED

Pursuant to the Authority's decisions dated September 17, 2013, December 10, 2014 and June 9, 2016 in the case of Engro Powergen Qadirpur Limited, Formerly Engro Energy Limited, (hereinafter "EPQL"), the fuel portion of energy charge part of tariff of EPQL is required to be adjusted for variation in HSD price(s).

The Authority in its collective and joint wisdom decided with consensus as under; which shall be hereafter called as decision of the Authority in the matter:-

"Based on revised HSD price of Rs. 311.320/Litre (inclusive of freight), the fuel portion of energy charge part of tariff of EPQL has been adjusted and indicated hereunder which shall be immediately applicable on units delivered basis:
