## Subject: Decision of the Authority in the matter of Adjustment in Insurance Component of Capacity Charge Part of tariff from April 23, 2024 to April 22, 2025 for Engro Powergen Qadirpur Limited (EPQL)

Dear Sir,

Please find enclosed herewith the subject Decision of the Authority along with Annex-I (total 02 pages) regarding adjustment in insurance component of capacity charge part of tariff on account of Actual Insurance Premium for the period April 23, 2024 to April 22, 2025 in respect of Engro Powergen Qadirpur Ltd. in Case No. NEPRA/TRF-72/EPQL-2007.

DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE COMPONENT OF CAPACITY CHARGE PART OF TARIFF FROM APRIL 23, 2024 TO APRIL 22, 2025 FOR ENGRO POWERGEN QADIRPUR LIMITED (EPQL).

1. Pursuant to the decision of the Authority dated April 1, 2011 in the matter of Motion for Leave Review against the Authority's COD decision dated November 3, 2010 read with Corrigendum dated May 14, 2012, decision of the Authority dated September 17, 2013 in the matter of tariff adjustments on High Speed Diesel and mixed fuel and decision of the Authority dated June 9, 2016 regarding Engro Powergen Qadirpur Limited (EPQL), formerly Engro Energy Limited, the insurance component of tariff is subject to annual adjustment as per actual cost. EPQL requested to approve insurance component of Rs. 0.2187/kW/h and Rs. 0:2232/kW/h on Gas and HSD respectively, for the period of April 23, 2024 to April 22, 2025. EPQL in support of its request provided premium calculations and payment acknowledgment receipts of insurers. The details of requested insurance cost net of sales tax/FED is as under:

2. The Authority in its collective and joint wisdom decided with consensus as under; which will be hereafter called as decision of Authority in the matter:-

"Based on information and documentary evidence(s) provided by EPQL and in accordance with Schedule VIII of Power Purchase Agreement, the insurance component of capacity charge part of tariff of Rs. 0.2187/kW/h and 0.2232/kW/h for Gas and HSD respectively have been revised for the coverage period of April 23, 2024 to April 22, 2025 on the basis of net insurance cost of Rs. 416,254,617."

- 3. The above decision of the Authority along with revised tariff schedule attached as Annex-I are to be notified in the Official Gazette, in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
- 4. CPPA (G) to ensure that all payments are consistent with the tariff determinations.
