## DECISION OF THE AUTHORITY IN THE MATTER OF REVIEW MOTION FILED BY FIMCOTEX INDUSTRIES (PVT.) LIMITED (FIPL) AGAINST DETERMINATION OF THE AUTHORITY DATED 22<sup>ND</sup> JANUARY 2016

## **INTRODUCTION**

Fimcotex Industries (Pvt.) Limited (hereinafter referred as the "Petitioner") is a licensee of NEPRA vide 1.1 generation License No. SGCJ98/2014. The License was granted to the Petitioner to operate a thermal power plant (gas based) with 35.358 MW (Gross ISO) located at SITE Kotri, Sindh. The Authority had determined its generation tariff vide its Determination dated January 22, 2016 (Case No.NEPRA/TRF-294/FIPL-2015).

## **REVIEW MOTION** 2.0

- The Petitioner, vide Letter No. FIMCOTEX/ NEPRA Tariff / 2016 / 030, dated February 4, 2016 filed a 2.1 review Motion against the Authority's Determination dated January 22, 2016.
- The Authority on March 02, 2016 after detailed deliberations, besides condoning the delay in filing of 2.2 the Review Motion, admitted the same.
- Accordingly, the Hearing was fixed for 14<sup>th</sup> April 2016 which was re-scheduled for 10<sup>th</sup> May 2016 on the 2.3 Petitioner's Request.
- FIPL vide Letter dated 12<sup>th</sup> March 2018 requested to withdraw the Motion for Leave for Review. FIPL made certain additional requests in the letter, which were not relevant in the instant case, therefore are not considered.
- Since the Petitioner itself has requested to withdraw the review petition is dismissed as withdrawn. 2.5
