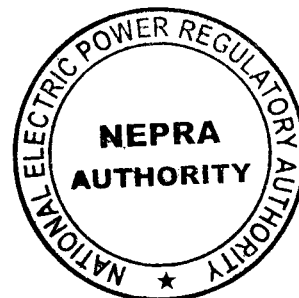

**DECISION OF THE AUTHORITY IN A MATTER OF PRE-COD FUEL PRICE
ADJUSTMENT IN THE TARIFF OF FAUJI POWER COMPANY (DAHARKI)
LIMITED (CASE NO. NEPRA/TRF-90/ FPCDL-2007)**


Pursuant to the Authority's decision dated September 18, 2008 and pursuant to Section 12.8 of Schedule-1 of the Power Purchase Agreement (PPA) signed between National Transmission and Despatch Company (NTDC) and Foundation Power Company Daharki limited (FPCDL) dated August 29, 2007, FPCDL's tariff has been adjusted for the variation in gas prices in order to recover the fuel cost component of FPCDL's tariff after synchronization prior to Commercial Operation Date (COD) from July 01 to December 31, 2009. The revised energy charge part of FPCDL's tariff relating to fuel indicated hereunder shall be immediately applicable on units delivered basis:



1.	July 01 to December 31, 2009	2.1806


