DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR FOUNDATION POWER COMPANY DAHARKI LIMITED

Pursuant to the Paragraph VII(iv) of Authority's decision dated 13th June 2008 in the case of Foundation Power Company Daharki Limited (hereinafter "FPCDL"), the fuel portion of energy charge part of tariff of FPCDL has been adjusted for variation in gas prices.
