Pursuant to the decision of the Authority dated 28th November 2013 in the matter of tariff adjustments at commercial operation date and decision of the Authority dated 20th December 2012 in the matter of change of index from WPI (Manufacture) to CPI (General) regarding Foundation Power Company Daharki Limited (FPCDL).
