
Dear Sir,


**Decision of the Authority in the Matter of Adjustment in Insurance Component of Capacity Charge
Part of Tariff for Hub Power Company Limited (HUBCO)**



2. The revised insurance component of tariff indicated hereunder shall be immediately applicable:





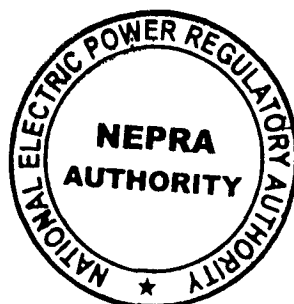
