
**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT  
FOR HALMORE POWER GENERATION COMPANY LIMITED**


Pursuant to the Authority's decision dated 26<sup>th</sup> December, 2007 in the case of Halmore Power Generation Company Limited (hereinafter "HPGCL"), the fuel portion of energy charge part of tariff of HPGCL has been adjusted for variation in HSD price. 


