


Decision of the Authority in the Matter of Adjustment in Insurance Component of Capacity Charge Part of Tariff for Halmore Power Generation Company Limited (HPGCL)


1. Pursuant to the decision of the Authority dated 6th November, 2014 read with corrigendum dated 4th December, 2014 in the matter of adjustment at Commercial Operation Date regarding Halmore Power Generation Company Limited (HPGCL), on the basis of information provided by HPGCL, the insurance components of capacity charge part of tariff have been revised on the basis of Insurance Premium net of Federal Excise Duty (FED).
2. The revised insurance component of capacity charge part of tariff indicated hereunder shall be immediately applicable:


