


**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE**  
**ADJUSTMENT BASED ON RLNG FOR HALMORE POWER GENERATION**  
**COMPANY LIMITED**

1. Pursuant to Decisions of the Authority dated December 26, 2007, November 6, 2014 and May 3, 2016, in the case of Halmore Power Generation Company Limited (hereinafter "HPGCL"), the fuel portion of energy charge part of tariff of HPGCL has been adjusted for variation in fuel price.
2. Oil & Gas Regulatory Authority (OGRA) vide its determination dated April 7, 2021 has determined provisional RLNG weighted average price for SNGPL for the month of April 2021. Based on OGRA's notification, the fuel cost components on RLNG of HPGCL have been revised. The revision has been made on provisional basis and final fuel cost components shall be made after notification of final RLNG price(s) by OGRA and submission of fuel invoice(s) by HPGCL. The revised fuel cost components are indicated hereunder and shall be immediately applicable on unit delivered basis:



3. In case, RLNG price is not changed or not determined by OGRA for the next period/month, fuel cost component effective from April 22, 2021 shall remain applicable.
4. The attached **Annex-I** is to be notified in the official gazette, in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997.
5. CPPA(G) to ensure that all payments are consistent with tariff determination(s).




