## ADJUSTMENT/INDEXATION THE MATTER OF **AUTHORITY** IN OF THE INSURANCE COMPONENT OF CAPACITY CHARGE PART OF TARIFF FOR HALMORE POWER GENERATION COMPANY LIMITED (HPGCL)

Pursuant to the decision of the Authority dated January 8, 2014 in the matter of tariff adjustments at 1. Commercial Operations Date (COD), decision of the Authority dated November 6, 2014 read with corrigendum dated December 4, 2014 in the matter of Motion for Leave for Review regarding Halmore Power Generation Company Limited (HPGCL), the insurance component of capacity charge part of tariff is subject to adjustment as per actual. HPGCL requested to approve insurance component of Rs. 0.3168/kW/h for the period June 15, 2023 to June 14, 2024. HPGCL in support of its request provided copies of premium invoices, payment evidences and quotations from insurance companies for current year i.e. 2023-2024. The details of requested insurance cost net of Federal Exercise Duty is as under:

"Based on the documentary evidences provided by HPGCL and in accordance with Schedule VIII of the Power Purchase Agreement, the insurance component of capacity charge part of tariff has been revised pertaining to coverage period of June 15, 2023 to June 14, 2024 (366 days)."
