Subject: Decision of the Authority in the matter of Fuel Price Adjustment for Huaneng Shandong Ruyi (Pakistan) Energy (Private) Limited (HSR) [Case No. NEPRA/TRF-308/HSRPEL-2015]

DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMNET FOR HUANENG SHANDONG RUYI (PAKISTAN) ENERGY PRIVATE LIMITED.

Pursuant to the decision of the Authority dated 31st March 2015 in the matter of approval of Upfront Coal tariff for 2x660 MW coal power plant of Huaneng Shandong Ruyi (Pakistan) Energy Private Limited (HSR) and the decision of the Authority dated 23rd September 2016 regarding Suo Moto Review Proceedings in the Fuel Price Adjustment Mechanism determined in Upfront Coal tariff, the fuel portion of the energy charge part of HSR's tariff has been adjusted for variation in coal price(s). HSR requested weighted average coal price of US\$ 168.59/ton for coal consumed during the month of April 2018. HSR further requested fuel cost component of Rs. 7.0889/kWh for April 2018 which was found on higher side. In accordance with the prescribed mechanism, the revised coal prices have been worked out and are attached as Annex-II. The revised fuel cost component of energy charge part of HSR's tariff indicated hereunder shall be immediately applicable to the units delivered during the month.

Inland freight charges have been worked out in accordance with the decision of the Authority dated 15th February 2018 in the matter of Inland Coal Transportation Agreement between HSR and Pakistan Railway Freight Transportation Company (Private) Limited (PRFTC) for transportation of coal from Port Qasim Karachi to Sahiwal. The subject decision is still to be notified in the Official Gazette. The freight charges have been included in the coal price on provisional basis and shall be subject to the Notification of the Order of the Authority by Government of Pakistan. The cost of spur line has been adjusted as per the actual quantities of coal handled in each month. The revised inland freight charges for each shipment is provided at Annex-IV.

HSR procured one shipment of 34,500 tons from Russia. The Authority vide its decision dated 23rd September 2016 while discussing the import of Columbian coal decided as "IPP should also be allowed to import coal from Columbia, as long as the delivered price to any of the Pakistan Port in terms of US\$/MMBTU is comparable to South Africa coal or Indonesia whichever is lower at that time". In accordance with decision of the Authority, the price of Russian Coal has been worked out in line with the CFR price of South African coal.

In case of Shipment No. HSR 57 and HSR 62, freight has been calculated on the basis 50,000 tons against the actual quantities of 34,500 tons and 38,147 tons. These two shipments were unloaded at PIBTL where the permissible draft limit of PIBTL is 13 m and Supermax vessel can be handled easily with capacity of 50,000 tons.

HSR continuing the practice of requesting PDA charges on estimated basis which needs to be discouraged. It is HSR responsibility to submit the details of actual PDA charges along







with documentary evidence. Accordingly, only actual PDA charges supported by documentary evidence have been considered for inclusion in the coal price.

The above referred revised fuel cost component along with revised coal prices, revised marine freight charges and revised inland freight charges attached as Annex-I, Annex-II, Annex-III & Annex-IV respectively are to be notified in the official gazette, in accordance with the provisions of Section 31(4) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
