

**SUO MOTO REVIEW PROCEEDINGS REGARDING INSERTION OF OMITTED CLAUSE
IN THE MATTER OF APPROVED UPFRONT COAL TARIFF DATED 31st MARCH 2015
FOR HUANENG SHANDONG RUYI (PAKISTAN) ENERGY (PRIVATE) LIMITED**

1. The Authority vide its decision No. NEPRA/TRF-308/HSRPEL-2015/4385-4387 dated 31st March 2015 approved upfront tariff in favor of M/s. Huaneng Shandong Ruyi (Pakistan) Energy (Private) Limited for its 1320 MW coal power plant.
2. An omission has been observed in the above decision wherein the following Clause could not be reflected in Para 3(II)(xviii);

"(8) The cost of lime stone and ash disposal will be adjusted on actual basis at the time of COD."

3. The Authority has therefore, decided to insert Clause 8 after the Clause 7 in Para 3(II)(xviii) of the above mentioned decision.



In pursuance of Section 7(2)(g) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 read with Regulation 3 of NEPRA (Review Procedure) Regulations, 2009 the Authority has decided to insert the following Clause 8 after Clause 7 under Para 3(II)(xviii) of the decision dated 31st March 2015 for M/s Huaneng Shandong Ruyi (Pakistan) Energy (Private) Limited notified vide SRO No. 560(I)/2015 dated 1st June 2015.

"(8) The cost of lime stone and ash disposal will be adjusted on actual basis at the time of COD."



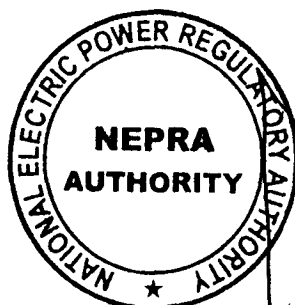
